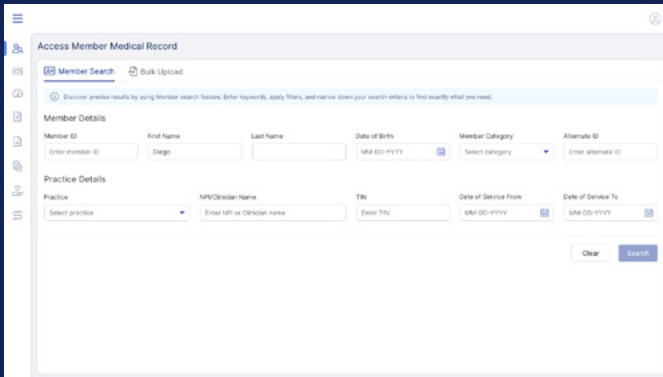
- Adult BMI up 25%

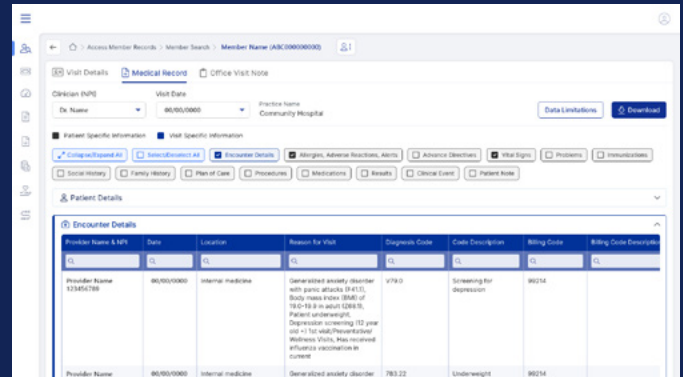

Exchange Nexus supports member search within the platform to allow for easy access to clinical data.

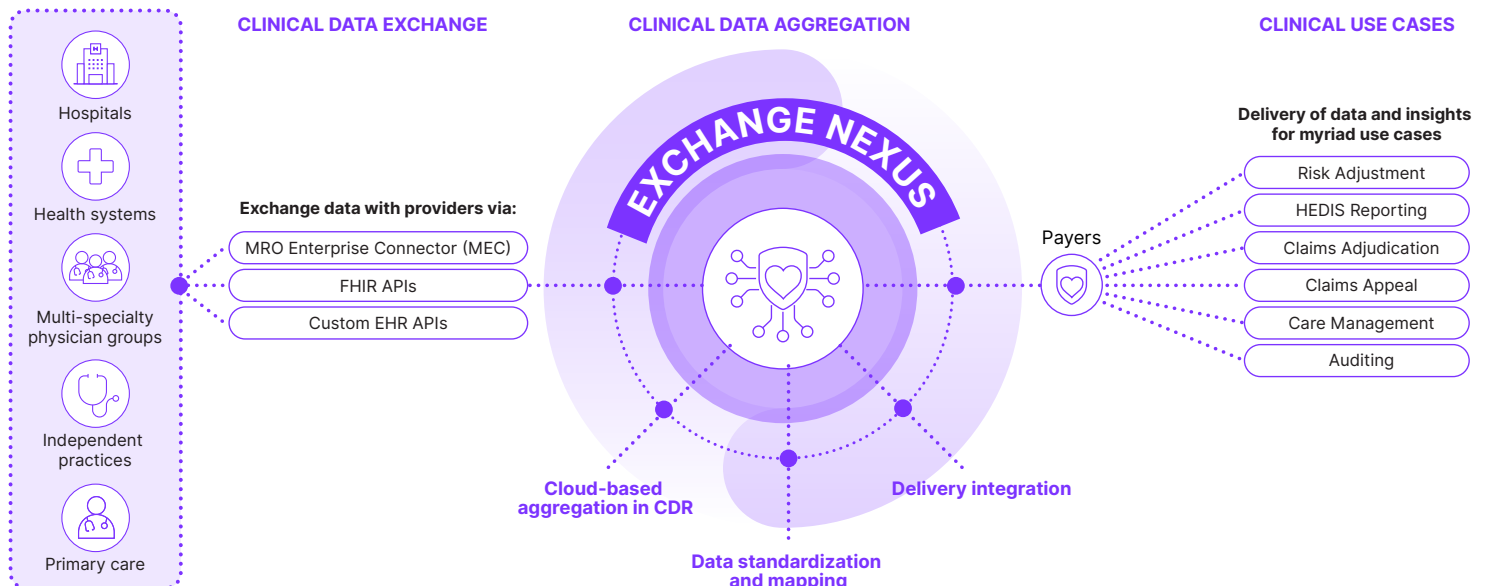


Member list is consistent with payer's member eligibility file and is continuously updated to ensure access to all relevant members in Exchange Nexus.
